Benefits at a glance

Individual artists can access up to 69kg of checked baggage (3 pieces of 23kg baggage) when travelling domestically within Australia on Virgin Australia (excludes Economy Lite fares).*

Eligibility

To be eligible for Virgin Australia's music industry baggage allowance, musicians must be financial or bona fide members of one of the following Australian Music Industry bodies:

- Musicians Union of Australia (MUA)
- MEAA Symphony Orchestra Musicians Association (SOMA)
- Australian Freelance Musicians Alliance (AFMA)
- Country Music Association of Australia (CMA)
- Australian Folk Alliance (AFA)
- Australian Chamber Orchestra (OCA)
- AMIN's member organisations: Queensland Music Network, Music Tasmania; Music NSW, Music NT, Music Victoria, MusicSA, MusicACT and The Western Australian Music Industry Association
- Phonographic Performance Company of Australia Limited (PPCA)
- Performing artist of the Adelaide Fringe Festival

How to book

Once you have booked a domestic flight with Virgin Australia, note your booking reference number.

Requests for the music industry baggage allowance to be added to your booking must be made at least **two days** before your scheduled departure.

*Music industry baggage allowance only available on domestic flights operated by Virgin Australia (excludes guests travelling on Economy Lite fares). Not available on Fokker, Embraer or ATR aircraft. Acceptance of music industry baggage is subject to availability and aircraft load restrictions. Velocity members may select either the music industry baggage allowance or tiered baggage allowance (not both). Platinum members booked on Business class not eligible for music industry baggage allowance. Each piece must not exceed 23kg; excess baggage fees will apply.
