I will comply with all applicable laws, including the IATA Live Animals Regulations, and Government Quarantine Regulations which govern the importation and exportation of animals; and</p> <p>4. I will ensure that the animal's cage or transportation container complies with all regulatory requirements and requirements of the VA Group; and</p> <p>5. I understand and accept that the transport of the animal by air has inherent risks, including an increased risk of mortality. Environmental conditions such as temperature, humidity and air density changes can occur in transit, departure or arrival ports. This may have a significant effect on the health and well-being of the animal, including increasing breathing difficulties in some breeds such as Brachycephalic and</p> <p>6. I acknowledge that the animal will not be accompanied or supervised, and I accept that the VA Group may not have the expertise or ability to access veterinary services or identify risks to the animal's health or well-being throughout the animal's journey.
