DECLARATIONS OF PARENT/LEGAL GUARDIAN (*Legal Guardian as approved by the courts)

- I am the parent/legal guardian of the child referred to above. I have legal responsibility for the child and give permission for him/her to travel unaccompanied with Virgin Australia.
- I confirm that:
 - The person assigned by me to escort the child at departure has been instructed to produce identification to check-in the child and to remain at the airport until the flight has departed;
 - The person assigned by me to collect the child on arrival has been instructed to attend the airport at the scheduled arrival time of the flight and will be required to produce identification to collect the child;
 - The person assigned by me to escort the child at departure and the person assigned by me to collect the child on arrival have been notified that Virgin Australia will handle their personal information provided on this form for the purposes of facilitating the travel of the unaccompanied minor, and otherwise in accordance with the Virgin Australia Privacy Policy.
 - The child has possession of all travel documents (passport, visas, health certificate etc.) and agree that Virgin Australia is not responsible for obtaining any travel documents that may be missing or defective;
 - All information provided on this form is correct;
 - Virgin Australia is unable to administer medication to the child and accordingly, is not responsible for or is in any way liable in respect of the administration (or non- administration) of such medication;
 - If the child carries a device onboard that is able to access Wi-Fi and Inflight Entertainment, Virgin Australia is unable to monitor the child's use of that device. There may be circumstances where the child accesses content that is not suitable for them, including MA15+ content. In these circumstances, you agree that neither the child nor anyone behalf of the child will have any claim against Virgin Australia or any of its officers, agents or employees in respect of the in- flight entertainment or internet content that is viewed by the child;
 - Virgin Australia only accepts credit/debit cards for in-flight food and beverage purchases. The child will not be served hot beverages. Please note: cash, prepaid cards and gift cards are not accepted for onboard purchases; and
 - I have read the 'Children Travelling Alone' section on the Virgin Australia website available here: <https://www.virginaustralia.com/au/en/travel-info/specific-travel/children/#unaccompanied> .
- Should the child not be collected on arrival and/or should the relevant flight/s be cancelled, delayed or diverted:
 - I authorise Virgin Australia to take whatever action it considers appropriate for the child having regard to the circumstances and for the child's safety and welfare, which may include returning the child to the airport of original departure or contacting Police if the child has not been collected;
 - I agree to reimburse Virgin Australia for all reasonable and substantiated costs associated with such care, including but not limited to transportation, meals, accommodation, and providing a carer for the child. However, this obligation does not apply to the extent you are entitled to receive compensation or assistance for such costs under Virgin Australia's Guest Compensation Policy or under applicable laws, including the Australian Consumer Law or international conventions; and
 - I authorise the first point of contact to be the parent or legal guardian nominated and I confirm that the nominated parent/guardian can be contacted at any time while the child named on this form is in Virgin Australia's care.
- I acknowledge that the child's travel is subject to Virgin Australia's Conditions of Carriage (available on the Virgin Australia website), applicable laws and airport security screening procedures (which may include explosive trace detection testing and body scanners).
- I agree to Virgin Australia collecting the child's personal information (including sensitive information such as health information, where relevant) for the purpose of facilitating this booking. I understand that the child's personal information may be disclosed to the person escorting the child and the person collecting the child and will otherwise be handled in accordance with the Virgin Australia Privacy Policy.
- Virgin Australia is not liable for any claim, action, loss, proceeding or demand by the child and/or any other person arising out of or in connection with the child's travel and/or care:
 - however arising, including, but not limited to, by the negligence of Virgin Australia and its agents, representatives, officers and employees;
 - whether present or future, fixed or unascertained, actual or contingent,
 except to the extent that Virgin Australia cannot exclude liability under any applicable law including the Australian Consumer Law and International Conventions.
